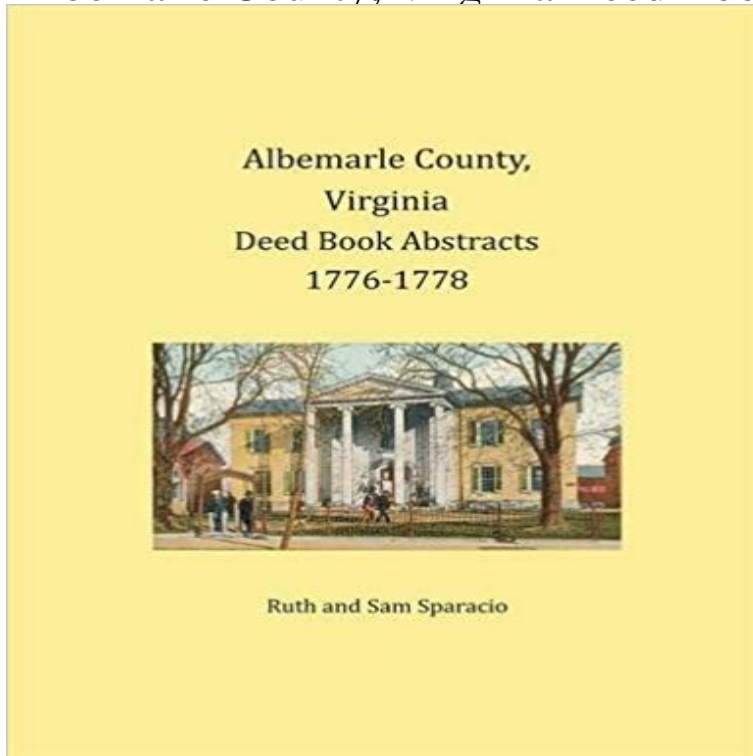


## Albemarle County, Virginia Deed Book Abstracts 1776-1778
